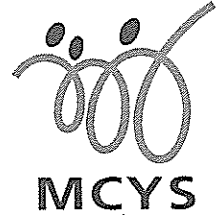

THE CHARITIES (FUND-RAISING APPEALS FOR FOREIGN CHARITABLE PURPOSES) REGULATIONS

The Commissioner of Charities, in pursuance of the provisions of the Charities (Fund-raising Appeals For Foreign Charitable Purposes) Regulations, hereby grant **Lotus Culture Ltd.** Permit No. 0068/2010 to raise funds from target group of donors during the period 24/10/2010 to 31/12/2010. The funds raised will be remitted to Agir pour les Femmes en Situation Precaire (AFESIP) to support its programs in providing assistance and rehabilitation to women and girls who have been victims of sex trafficking in Cambodia.
